The contents listed below are not accessible for the following reasons: failure to comply with law 9 January 2004, n. 4:

- Criterion: 9.1.3.1 - In some cases, information, structure or correlations conveyed by the presentation of the pages cannot be determined programmatically (or are not available via text);
- Criterion: 9.1.4.4 - Some texts, except subtitles and images containing text, cannot be resized up to 200 percent without using assistive technologies and without losing content and functionality;
- Criterion: 9.2.2.1 - There is a time-dependent item or event where even one of the following is not possible: turn off time limit before reaching it, adjust time limit, cannot extend up to 10 times, user is not warned beforehand of the expiration of the time, except for exceptions provided for by law;

- Criterion: 9.3.2.4 - Some components with the same functionality within a set of web pages are not consistently identified;
- Criterion: 9.3.3.1 - In some cases, when an insertion error is automatically detected, the item in error is not identified and/or the error is not described in text;
- Criterion: 9.3.3.2 - In some cases, no labels or instructions are provided when the content requires user input;
- Criterion: 9.4.1.1 - The page markup code does not always conform to its specifications or contains errors, or duplicate attributes and IDs;
